Qualified Entrant and Entry

Contest Conditions

- \$10,000 total chips (TC) / 15-minute blind level.
- Up to twenty (20) levels of play.
- Forty (40) players maximum per Tournament Day.
- Tournament seats are non-transferrable and non-refundable.
- Available to all carded and uncarded players.

Registration for the Monday Bounty Poker Tournaments

- **Pre-registration opens on every Tournament Day - Mondays at 5:00PM PT, two (2) hours prior to the Tournament.**
- **Check-in opens on Mondays at 6:30PM to 6:45PM PT on event days. Pre-registered participants must complete registration (buy-in) at the time of check-in.**
- All Entrants must register in-person – no third-party registrations, phone-ins, or emails.
- Buy-in is non-refundable and non-transferable. By not completing full registration, players may forfeit their seat and registration fee.
- Late Entry is open until the end of level three (3) if seats are available.

Prize Claiming Conditions for the Monday Bounty Poker Tournaments
