Qualified Entrant and Entry

- A qualified entrant ("Entrant") is 19 years of age or older and has earned a ballot ("entry") by complying with the "**Contest Details for Poker Splash Pot Spree**" and "**How to Earn Entries into the Draws for Poker Splash Pot Spree**" sections below.
- The following persons are not eligible to participate in the contest and, thus, cannot be Entrants:
 - Employees of River Rock Casino Resort ("RRCR"), and its subsidiaries and affiliates, and the British Columbia Lottery Corporation ("BCLC"), as well as family and household members of same who reside at the same address.
 - Patron on Game Break, RRCR site barred and BCLC provincial barred persons, and residents of Québec.
- Entrants and Entries must meet and adhere to all contest rules as outlined herein. Entrants and/or Entry not meeting such rules will be disqualified and any potential prize will be forfeited.
- A qualified contestant ("Contestant") is any Entrant who has been selected based on the "**Draw Procedure for the Poker Splash Pot Spree**" section embedded within.

Contest Details for Poker Splash Pot Spree

- The Contest Period runs **from 5:00PM PT on Sunday, August 2, 2026, to 8:00PM PT on Thursday, September 3, 2026**, with splash pots taking place **daily Sunday to Thursday at 5:00PM, 6:00PM, 7:00PM & 8:00PM PT** in the Poker Room at River Rock Casino Resort.
- A total of one hundred (100) splash pots for all active Poker tables will take place during the Contest Period.

Prizing for Poker Splash Pot Spree

- At each draw time, one (1) active Poker table will be randomly selected to receive a \$100 Splash Pot.
- Once the winning table has been selected, the Poker Supervisor will add \$100 in chips to the pot immediately prior to the next hand following the scheduled Splash Pot draw time.
- Regular rake and BB/GC Board Rake will continue to be collected as normal.
- Splash Pot prize pool calculation: \$100 per Splash Pot × four (4) Splash Pots per day × five (5) promotional days per week × five (5) weeks = **\$10,000 total cash prize pool**.

How to Enter into the Poker Splash Pot Spree

1. Earning Entry through Playing Poker

- To be eligible, entrants must be seated at an active Poker table in the Poker Room at River Rock Casino Resort during the scheduled Splash Pot times on Sundays through Thursdays at **5:00PM, 6:00PM, 7:00PM, and 8:00PM PT.**
- The Poker table must have been open and in active play for at least one (1) continuous hour prior to the scheduled Splash Pot draw.
 - **Example:** If Table #2 opens at 4:15 PM, it is not eligible for the 5:00PM Splash Pot draw, but it will be eligible for the 6:00PM Splash Pot draw.
- Poker Tables are defined as Public Live Games. Tournament play and Private Games are not eligible for this Promotion.
- Available to all carded and uncarded players.
- Entrant(s) must be present to win.

2. "Self-Addressed Stamped Envelope" Entry ("SASE Entry")

- No purchase necessary. Anyone may request one (1) Entry in writing by delivering a self-addressed, stamped envelope (which must be received during the Contest Period) to "Poker Splash Pot Spree" c/o **River Rock Casino Resort Guest Services, 8811 River Road, Richmond BC, V6X 3P8**. The Entry must include their full name, Date of Birth, phone number, and Encore Rewards number. The Entrants are responsible to ensure that entries arrive on time; as set out below, RRCR is not responsible for any lost, misdirected, or incomplete entries.

Draw Procedure for the Poker Splash Pot Spree

A Table Games Manager/ Poker Supervisor will conduct the splash pot draws **daily Sunday to Thursday at 5:00PM, 6:00PM, 7:00PM & 8:00PM PT:**

- At each scheduled Splash Pot time, the Draw Conductor will announce the Splash Pot draw and use the spin wheel to randomly select one (1) eligible active Poker table.
- Once the winning table has been selected, the Poker Supervisor will add \$100 in chips to the pot immediately prior to the next hand following the scheduled Splash Pot time.
- Regular rake and BB/GC Board Rake will continue to be collected as normal.
- In the event that there is a side pot, the splash pot prize will remain within the main pot. The Winner of the side pot will not be eligible to receive any portion of the splash pot chips.
- Participant will be instantly rewarded the chips in the Poker Room at the end of the hand.
- Once the player is found; they will have their ID verified through iTrak.
- After the player is verified, they will receive their respective cash prize.
 - If the Winner is not eligible to win or decline their prize, a new Winner will be chosen under the same process to win the same splash pot prize in the following hand.
 - The above process will occur until a Winner is present.

Prize Claiming Conditions for the Poker Splash Pot Spree

- Winner must remain seated at the time of the Winner selection and confirmation.
- To become a Winner, a Contestant will be required to:
 - Present valid government issued or other valid official identification reasonably establishing the identity of the holder in the sole discretion of RRCR, such as a driver's license, passport, or citizenship card.
