Qualified Player

- A qualified player (“Player”) is 19 years of age or older and has earned an entry (“entry”) by complying with the **“Promotion Details for Electronic Table Games Lucky Scratch”** and **“How to Earn Entries into the promotion for Electronic Table Games Lucky Scratch”** sections below.
- The following persons are not eligible to participate in the promotion and, thus, cannot be Players:

Offers for Electronic Table Games Lucky Scratch

- **A total of forty (40) Mystery Card Offers will be available weekly over thirteen (13) weeks**, during the promotional period from July 5 to October 3, 2026.

Participation and offer availability are primarily triggered through Electronic Table Games play and in-person redemption.

Offer Claiming Procedure for the Electronic Table Games Lucky Scratch
