Qualified Entrant and Entry

- A qualified Entrant (“Entrant”) is 19 years of age or older and has earned a ballot (“entry”) by complying with the **“Contest Details for Privé Golden Moon Fortune”** and **“How to Earn Entries into the Draws for Privé Golden Moon Fortune”** sections below.
- The following persons are not eligible to participate in the contest and, thus, cannot be Entrants:
 - Employees of River Rock Casino Resort and its subsidiaries and affiliates, and the British Columbia Lottery Corporation (“BCLC”), as well as family and household members of same who reside at the same address;
 - Voluntary self-excluded (Gamebreak), River Rock Casino Resort site barred and BCLC provincial barred persons; and Residence of Quebec.

Contest Details for Privé Golden Moon Fortune

- The Contest Period runs from **7:00AM PT Sunday, August 30, 2026, to 11:00PM PT Saturday, September 26, 2026**.
- Draws will take place every:
 - Wednesday: September 2, 9, 16 & 23 at 8:00PM and 10:00PM PT**
 - Saturday: September 5, 12, 19 & 26 at 9:00PM and 11:00PM PT**
- Entry ballots for the draws may be earned starting at 7:00AM PT Sunday, August 30, 2026.
- The participating sites will be River Rock Casino Resort.

Prizing for Privé Golden Moon Fortune

- At each draw time, one (1) Entrant will be selected to choose a prize, except for the draw on September 26, 2026, at 11:00PM PT.
 - The selected winner will choose one (1) of fifteen (15) game pieces to reveal their prize.
 - Once a game piece has been selected, it will be removed from the game board and will no longer be available.
- On September 26, 2026, at 11:00PM PT, three (3) Entrants will be selected to each choose one (1) of three (3) game pieces to reveal their cash prize.
 - Once a game piece has been selected, it will be removed from the game board and will no longer be available.

How to Earn Entries into the draws for Privé Golden Moon Fortune

There are **two (2) ways** to enter the **draws**: Earning Entry through Slot Play, or with a “Self-Addressed-Stamped Envelope” alternative.

1. Earning Entry through Slot Play

- One (1) ballot can be earned by an Entrant for every **3,000** Encore Rewards points earned when playing any slot machine daily.
 - Maximum of twenty (20) ballots per gaming date.
- Entrant(s) are eligible to earn and receive unlimited ballots anytime during the earning period.
 - Ballots can be earned until 10:55PM PT Saturday, September 26, 2026.
- A River Rock Casino Resort Employee **must** fill out the Entrant’s Encore Rewards number and their GAMW# on the ballot.
- CMP Prize Code for ballot tracking off earned points: **(RIC-GMFBAL)**.
- Must be a 2026 Privé Member.

2. “Self-Addressed Stamped Envelope” Entry (“SASE Entry”)

- No purchase necessary. Anyone may request one (1) Entry in writing by delivering a self-addressed, stamped envelope (which must be received during the Contest Period) to “**Privé Golden Moon Fortune**” c/o **River Rock Casino Resort Guest Services, 8811 River Road, Richmond BC, V6X 3P8**. The Entry must include their full name, Date of Birth, phone number, and Encore Rewards number. The entrants are responsible for ensuring that entries arrive on time; as set out below, River Rock Casino Resort is not responsible for any lost, misdirected, or incomplete entries.
- Entries by the SASE Entry are limited to one (1) Entry per Entrant for the Contest Period.

Ballot Tracking

- Ballots removed from Guest Services must be recorded on the “Ballot Inventory Tracking” spreadsheet.
- Team members must indicate the number of ballots removed, the date removed, the corresponding serial numbers, and the updated ending balance, along with their department, initials, and GPEB.

Draw Procedure for the Privé Golden Moon Fortune

Two (2) registered River Rock Casino Resort gaming employees will conduct draws:

- **The draw barrel will be sealed one (1) minute prior to the draw time.**
- One (1) Entrant will be selected at random at each draw time (Wednesdays: 8:00PM & 10:00PM PT, Saturdays: 9:00PM & 11:00PM PT) through the ballots that were entered to the draw, except for the draw on September 26, 2026, at 11:00PM PT.
- On September 26, 2026, at 11:00PM PT, three (3) Entrants will be selected to each choose one (1) of three (3) game pieces to reveal their cash prize.
 - The selected Entrants will choose their game pieces in the order in which their names were drawn.
- Once the player is selected, the Drawn Entrants’ name will be announced via PA system multiple times and Contestant is required to identify themselves within two (2) minutes of the first announcement.
 - If no Winners are present for the draw, unlimited draws will occur until a Winner is found. Within each redraw, one (1) unique name will be drawn.
 - Entrant(s) that are redrawn during a redraw will not be eligible to participate during the same draw time.
 - Example: If Player A was drawn at 8:00PM draw and does not show up after two (2) minutes, and Player A was drawn again during the redraw, they will not be eligible to claim the prize. Another player must be drawn for the 8:00PM draw time.

Prize Claiming Conditions for Privé Golden Moon Fortune

- To become a Winner, a Contestant must:
 - be nineteen (19) years old or older on the date on which the prize is granted.
 - Present valid government issued photo ID establishing the identity of the holder in the sole discretion of River Rock Casino Resort, such as a driver's license, passport, or citizenship card.

 - Complete a BCLC Winner's Release form and/or the River Rock Casino Resort Winner's Release form before prize is released.

 - *Example: If an Entrant wins both draws on Wednesdays (8:00 PM and 10:00 PM), they will be ineligible to participate in or win either of the subsequent draws on Saturday (9:00 PM and 11:00 PM) of that same Draw Week. Alternatively, an Entrant may win one (1) draw on Thursday and one (1) draw on Saturday, or the Entrant can win both draws on Saturday (9:00 PM and 11:00 PM).*
- **Earned ballots will be emptied from the draw barrel at the end of the 11:00PM draw each Saturday. Once the draw barrel is cleared new entries can be deposited for the following week's draw.**
 - Ballots emptied must be stored in a secure bag and separated by promotional draw date.
 - A tag must be placed on the stored bag with the promotion name, draw date, and draw times.
 - Secure bags cannot be combined with other weeks' draws.
 - For example: Ballots that are entered into the week 1 draw, then emptied, cannot be combined in the secure bag for week 2's draw.
